### 15 Description of Equipment or Protective System

The Wolf Rechargeable Torch R-30 uses a halogen bulb and rechargeable battery with an electronic control circuit housed in a right-angled anti-static thermoplastic body. The rubber armoured lens ring and end cap retain either a coated polycarbonate or toughened glass lens.

The enclosure is sealed dust tight and provides an ingress protection level of IP67. The right-angle body arrangement incorporates a replaceable thermoplastic belt clip for hands-free use.

The Rechargeable Torch R-30 must be charged in a non-hazardous area with a charger having an output voltage not exceeding 14V:  $U_0 = 14V$
